REQUIRED AND ACCEPTABLE IDENTIFICATION DOCUMENTS FOR LIMITED PURPOSE CREDENTIAL APPLICANTS

All acceptable documents presented for verification or proof must be valid (current and not expired) and reflect the same name. One document "may not" satisfy more than one group unless CSOSA/DOC.

Converting DC DMV REAL ID to Limited Purpose: Must provide valid DC DMV REAL ID (Black Star located on top right) credential and complete proof of SSN ineligibility form. Two (2) proofs of DC Residency required only for change of address. Applicants who have not been issued a DC DMV REAL ID credential will need to refer to process listed below and provide required documents.
