**REQUIRED AND ACCEPTABLE IDENTIFICATION DOCUMENTS FOR
LIMITED PURPOSE CREDENTIAL APPLICANTS**

All acceptable documents presented for verification or proof must be valid (current and not expired) and reflect the same name. One document "may not" satisfy more than one group unless CSOSA/DOC.

If name is different than the name on passport or Consular Card, one document from the items listed below must be provided to link both names.
<p>Primary Source Documents:</p> <ul style="list-style-type: none"> Unexpired Passport Consular Card US Birth Certificate or birth certification card filed with a State Office of Vital Statistics (Original or Certified Copy) **DMV Approved Document with photo from Court Services and Offender Supervision (CSOSA) or DC Department of Corrections Issued within 60 days of application (Identification Card Only) <p>Secondary Source Documents:</p> <ul style="list-style-type: none"> Foreign Birth Certificate (Original or Certified Copy) Unexpired Foreign Driver License or Identification Card Unexpired United States Military or Dependent Identification Card Certified School Records 	<ul style="list-style-type: none"> Utility bill (water, gas, electric, oil, or cable), issued within the last 60 days (disconnect notices/bills are not accepted) Telephone bill (cell phone, wireless, or pager bills acceptable), issued within the last 60 days (disconnect notices/bills are not accepted) Deed, mortgage, or settlement agreement issued within the last 60 days Unexpired lease or rental agreement with the name of the applicant listed as the lessee, permitted resident, or renter (may be a photocopy) Unexpired Sublease accompanied by the original unexpired Lease with the name of the certifier as sub-lessor DC property tax bill issued within the last 12 months Unexpired homeowner's or renter's insurance policy reflecting name and address **Letter with picture from Court Services and Offender Supervision Agency (CSOSA) or DC Department of Corrections (DC DOC) certifying name and DC residency issued within the last 60 days (Identification Card Only) **DC DMV Proof of Residency Certification Form signed by the certifier residing at the residence AND a copy of certifier's unexpired DC driver license or DC identification card AND 2 proof of residency documents (i.e., utility bill, telephone bill, etc.) in the certifier's name Bank/Credit Card/Investment Account Statement issued within the last 60 days Official Mail—received from ANY government agency (with full name and address) to include contents and envelope received within the last 60 days, excluding mail from DC DMV (Change of Address Notifications from the Postal Service are NOT accepted) **DC DMV-approved form from certified social service provider (Identification Card Only) Medical Bill issued within the last 60 days Student Loan Statement issued within the last 60 days Home Line of Equity Statement issued within the last 60 days Car/Personal Loan Statement (no coupon books/vouchers accepted) issued within the last 60 days Home Security System Bill issued within the last 60 days 	<ul style="list-style-type: none"> Utility bill (water, gas, electric, oil, or cable) (disconnect notices/bills are not accepted) Telephone bill (cell phone, wireless, or pager bills acceptable, disconnect notices/bills are not accepted) Deed, mortgage, or settlement agreement Unexpired Lease or Rental Agreement with the name of the certifier as a lessor, lessee, permitted resident or renter (may be a photocopy) Unexpired Sublease accompanied by the original unexpired Lease with the name of the certifier as sub-lessor DC Property Tax Bill Unexpired Homeowner's or Renter's Insurance Policy reflecting name and address **DC DMV Proof of Residency Certification Form signed by the certifier residing at the residence AND a copy of certifier's unexpired DC driver license or DC identification card AND 2 proof of residency documents (i.e., utility bill, telephone bill, etc.) in the certifier's name Bank/Credit Card/Investment Account Statement Official Mail—received from ANY government agency (with full name and address) to include contents and envelope, excluding mail from DC DMV (Change of Address Notifications from the Postal Service are NOT accepted) **DC DMV-approved form from certified social service provider (Identification Card Only) Medical Bill Student Loan Statement Home Line of Equity Statement Car/Personal Loan Statement (no coupon books/vouchers accepted) Home Security System Bill 	<ul style="list-style-type: none"> Certified Marriage Certificate Divorce Decree Official US Court Order for Change of Name

**Does NOT require a second source of residency document.
