**REQUIRED AND ACCEPTABLE IDENTIFICATION DOCUMENTS FOR  
LIMITED PURPOSE CREDENTIAL APPLICANTS**

All acceptable documents presented for verification or proof must be valid (current and not expired) and reflect the same name. One document "may not" satisfy more than one group unless CSOSA/DOC.

If name is different than the name on passport or Consular Card, one document from the items listed below must be provided to link both names.
